Competence, confidence, congruence, commitment and more than that character etc, are the most essential needs of the teacher. The students, society and nation constantly monitor and scrutinize the teacher. There should not be any incompatibility between preaching and practice, precepts and implementations. So, a teacher should show calmness, patient and communicative temperament. A teacher should be a role model to the students and to the society.

1. I. TEACHERS AND THEIR RESPONSIBILITIES:

Whoever adopts teaching as a profession assumes the obligation to conduct himself / herself in accordance with the ideal of the profession.
