Conditions:

- 1) The college must comply with the conditions laid down by LIC and Academic council.
- 2) Bengaluru Central University will not grant permission for intake of excess students to any course.
- 3) Without the permission of Bengaluru Central University New sections cannot be opened under any course offered by the college.
- 4) Students admitted to various courses are subjected to rules pertaining reservation revised by the Government of Karnataka through circulars from time to time.
- 5) The college must abide by the guidelines/ bylaws and notification issued by the Bengaluru Central University. With regard to students. Teaching staff, the college must follow affiliation rules with regard to number of students admitted to a course and adhere to minimum gratification required for such admissions, any violation will not be condoned.
- 6) The college must fill up 50% of seats (Government College 100%) in P.G courses by students sponsored by Bengaluru Central University, such students must be changed, university stipulated in admission and other miscellaneous fees.

- 7) In accordance with the judgement of Supreme court V/S Government of Rajasthan in the order dated 13-08-1979. It has been stated that any lady employee or student in college Office must not be subjected to any kind of sexual harassment. Any member of staff/ management or office or students who commits such an act liable for punishment. Every college shall establish such a compliant cell to combat such instances.
- 8) Every college shall strive to enhance educational standards by making improvements in the curriculum. The college management must treat student, staff in the compassionate manner.
- 9) The college shall not retain marks card and other documents of students for more than six months. After University approves admission of students immediately college shall return marks cards and other documents of students and inform the same to the university.
- 10) If you student desired a transfer certificate the college shall issue it immediately. The college must refund all other fees except tuition fees, for the term / year. The college cannot collect any extra fees.
- 11) The college shall not collect any kind of capitation fee.
- 12) In the administrative matters Kannada must be compulsorily used.
- 13) The college must compulsorily submit the application form for the renewal of affiliation for the academic year 2019-20.
- 14) The colleges which have finished five years of commencement of the college must be NAAC accreditation as soon as possible.
- 15) Principal must submit a list of eligible valuers for valuation work to the custodian of Board of Examiners otherwise the college affiliation will be cancelled.
